#### 1.1. Programme Title

#### 1.2. Academic Unit Involved in the Delivery of the Programme

The Minor Programme in Entrepreneurship and Innovation is to be offered by the Entrepreneurship and Innovation programme and administered under the Faculty of Business and Management

#### 1.3. Programme Aims, Objectives and Intended Learning Outcomes

In today's uncertain environment, many young people struggle to find their identity, understand their environment, and chart their course. Priorities are difficult to establish and choices are not easy to make when confronted with the complexity, instability and ongoing change of contemporary life. The Minor Programme in EPIN aims to significantly enhance the educational experience of students while better preparing them to deal with the world around them. The focus here is on developing students' entrepreneurial mindset and their ability to cultivate critical skills to think and act in more creative, innovative, opportunistic and proactive ways.

To achieve these aims, the design and structure of the Minor Programme in EPIN include required and elective courses with solid experiential content, and provide opportunities for entrepreneurs to share their valuable experiences with students through workshops, entrepreneurial seminars and field trips to start-ups and large business enterprises.

In sum, the aims and objectives of the Minor Programme in Entrepreneurship and Innovation are:

- (1) to apply diverse concepts of business and society and to develop creative capacities that are essential to initiate, build, and grow business ventures;
- (2) to nurture entrepreneurial spirit and competencies by applying business-related knowledge and skills to develop and implement innovative ideas required for sustaining and growing organizational and new business undertakings.

#### 1.6. Year of Implementation

The Minor Programme in Entrepreneurship and Innovation has been offered from the Academic Year of 2020-2021.

#### 2. Programme Requirements and Structure

#### 2.1. Programme Requirements

The Minor Programme in Entrepreneurship and Innovation aims to provide opportunities for students to pursue their interest in entrepreneurship and innovation management and to develop their skills applicable to the business world. Students can claim the Minor Programme in Entrepreneurship and Innovation if they can fulfil the following criteria:

- a) Complete 15 units in accordance with the stipulated programme structure as in Table 3; and
- b) Attain a minimum cumulative GPA of 2.0 for all the 5 courses to be completed.

#### 2.2. Programme Structure

The Minor Programme in Entrepreneurship and Innovation consists of 1 required course followed by 4 electives from the list of elective courses as stipulated in Table 3. Students are required to complete at least one course at level 3 or above.

Students have to take EPIN3003. For non-BBA students, they have to take 12 units from

#R-EPIN-ELECT-001 and #R-EPIN-ELECT-002. Students who have taken any of the above courses in their major programmes have to take additional elective course(s) to fulfil the minor programme requirement.
